## ORDINANCE HO. 68\_

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA TO INCLUDE CERTAIN PLATTED LAND ABUTTING THE VILLAGE LIMITS

WHEREAS, a dertain petition dated April 26, 1966, requesting annexation of certain territory was duly presented to the Council on the <sup>26</sup>th day of April, 1966, and

WHEREAS, an amended petition dated May 11, 1966, requesting annexation of the territory hereinafter described was duly presented to the Council on the 14th day of July, 1966, and

WHEREAS, the quantity of land embraced within the area described in the amended petition and bounded as described is approximately 16 acros of platted land, no part of which is included within the limiteof an incorporated elty, village or becough; and

WHEREAS, the position was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WEEREAS, the land described in the petition abute upon the Village limits at the northerly boundary thereof; and

WHEREAS, copies of said Petition have been filed with the Municipal Commission the Town Board of the Town of Chisago Lake, and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be opposed in located, and
