
Dear Mr. Stacy:

ORDINANCE NO. 1897

RECORDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ADJACENT THE CITY OF AUSTIN LIES.

WHEREAS, a certain petition dated October 3, 1966, requesting annexation of the territory described herein was duly presented to the Common Council on the 3rd day of October, 1966, and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is approximately one-fourth ~~ACRE~~ of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all of the owners, and

WHEREAS, the South 66 ft. was owned by the City of Austin having been previously deeded to it, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, the land described hereinafter abuts the city limits on the West boundaries thereof.

NOW, THEREFORE, the Common Council of the City of Austin do ordain:

SECTION 1: The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected, that the territory described herein abuts the City limits and is urban or suburban in character and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Lot Four (4) in the Plot of Real Subdivision, a subdivision of Outlet Mine (9) in the Northeast Quarter (NE<sup>1/4</sup>) of the Northwest quarter of Section Four (4), Township 102 North, Range 18 West, and the street right of way abutting said lot to the south, now known as 6th Avenue N.W. being 66 ft. in width and lying adjacent to said Lot Four (4).

SECTION 3: The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, Secretary of State and the County Auditor.
