ORDINANCE NO. 197

AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF STAPLES TO
INCLUDE CERTAIN PLOTTED LAND NOT
INCLOSING TWO HUNDRED ACRES

Section I. A petition has been filed with the governing body
body of the City of Staples, Minnesota, by all of the owners of the
following described real estate to have such land included within
the City of Staples, Minnesota:

All of Lot Four (4) of Block Four (4) and
All of Lot Three (3) of Block Four (4) of Wilson's
First Addition to Staples; also described as all
of Lot Three (3) of Block Four (4) of Wilson's 1st
Addition to Staples, including all streets and
alleys contained therein and abutting thereon.

Section II. The quantity of land embraced within the foregoing
description and bounded as described is about one-half (1/2) acre.

Section III. The City Council hereby determines (a) that the
annexation will be to the best interests of the City of Staples,
Minnesota and of the territory affected; (b) that the territory
affected abuts upon the City and is so conditioned as properly to be
subjected to City government.

Section IV. Therefore, the City of Staples, Minnesota, hereby
ordains and declares that the property hereinbefore described be and
the same is hereby annexed to, and included in, the City of Staples,
as effectually as if it had originally been a part thereof.

Section V. This ordinance shall be final and shall take effect
and be in force from and after filing a certified copy thereto with
the Minnesota Municipal Commission, the County Auditor, the Secre-
tary of the State of Minnesota and from and after its passage and
publication.
