ORDINANCE NO. 310

AN ORDINANCE ANNEXING CERTAIN  
PROPERTY TO THE CITY OF THIEF  
RIVER FALLS

The City Council of the City of Thief River Falls do hereby  
ordain as follows:

Section 1.

WHEREAS the City of Thief River Falls is the owner in fee  
of the following described property; that said territory abuts on  
the corporate limits of said City of Thief River Falls; that said  
territory is not included within the corporate limits of any  
other municipality; therefore the City of Thief River Falls,  
pursuant to the provisions of Chapter 414.03 of the Minnesota  
Statutes, hereby annexes and incorporates within its boundaries  
the following described property:

Government Lot Eight (8) and all that part of Government  
Lot Nine (9) lying North of the right-of-way line of  
Minnesota State Trunk Highway No. 1, and the West Five  
Hundred Feet (500') of the South Half of the Southeast  
Quarter (S $\frac{1}{2}$  SE $\frac{1}{4}$ ) of Section Twenty-seven (27) in Town-  
ship One Hundred Fifty-four (154) North of Range Forty-  
three (43) West of the Fifth Principal Meridian less  
highway right-of-way and less that portion thereof  
previously conveyed to Thief River Falls Foundation by  
a deed dated March 23, 1960 and recorded in Book 89 of  
deeds on page 577 of the records in the Office of the  
Register of Deeds of said County and State.

Section 2.

This ordinance shall be in force and effect from  
and after its passage, approval, publication and filing.
