ORDINANCE NO. 150 -C-CHAPTER XW.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE CER-TAIN UNINCORPORATED UNPLATTED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING THE VILLAGE LIMITS.

WHEREAS a certain petition dated September 7th, 1966, requesting annexation of the territory hereinafter described was duly presented to the Village Council of the Village of Sartell on the 17th day of September, 1966; and,

WHEREAS the quantity of land embraced within the area described in the petition and bounded as described is 10.75 acres of unplatted/platted land, no part of which is included within the limits of the incorporated city, village or borough; and, WHEREAS the petition was signed by all of the owners of said land; and, WHEREAS no objection to the annexation has been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS, the land described in the petition abuts upon the Village Limits at the Easterly boundary thereof; NOW, THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

<u>Subsection 1.</u> The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory annexed; that the territory described herein abuts upon the Village Limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any City, Village or Borough.

<u>Subsection 2. Territory Annexed.</u> The corporate limits of the Village of Sartell are hereby extended to include the unplatted/platted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"All that part of the Southwest Quarter (SN₂) of Section Ten (10), Township Thirty-Six (36) North, Range Thirty-One (31) West, Benton County, Minnesota, described as follows: Beginning at the Southwest corner of Section 10, Township 36 N., Range 31 W., Benton County, Minnesota; thence North 00° 41' West on West line of Section 10. Township 36, Range 31, a distance of 792 feet; thence East a distance of 796.75 feet; thence South 30° 05' 39" West a distance of 582.38 feet; thence South 288.11 feet to South line of Section 10; thence West on said South line of Section 10 a distance of 495.28 feet to the point of beginning, containing 10.75 acres, more or less, subjecto all easements of record and subject to County Read, said premises being platted as "Hillcrest Addition".

Subsection 3. Filing. The Village Clerk is hereby directed to file certified copies of this Oxidinance with the Dinnesota Dunicipal Commission, the Secretary of State, and the County Auditor of Senton County, Dinnesota.
