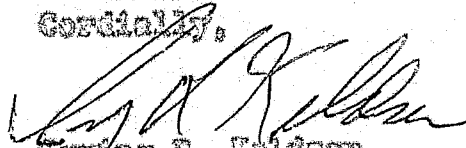
Dear Mr. Stacy:

ORDINANCE NO. 1030

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition dated February 15, 1966 requesting annexation of the territory hereinafter described was duly presented to the council on the 21st day of February, 1966; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 5.4 acres of platted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the Petition was signed by 15 owners, constituting a majority but not all of a total number of 19 owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the City of Austin, Minnesota, on the proposed annexation after at least 30 days posted notice; and

WHEREAS, the land described in the Petition abuts upon the City limits at the west boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN ORDAINS:

SECTION 1. The City Council hereby determines that the annexation will be to the best interest of the City and of the territory affected, that the territory described herein abuts upon the city limits and is urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2. Territory Annexed. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City of Austin as effectually as if it had originally been a part thereof:

Lots 1, 2 and 3 in Block 1, Lots 1, 2 and 3 in Block 5, Lots 7, 8 and 9 in Block 2, and Lots 7, 8, 9, 10, 11 and 12 in Block 4 in Nob Hill First Addition, and Lots 1, 2, 3 and 4 in Block 5, Nob Hill Second Addition.

SECTION 3. Filing. The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

SECTION 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
