
Dear Mr. Straiff:

ORDINANCE ANNEXING CERTAIN LANDS

TO THE

VILLAGE OF STEWARTVILLE

WHEREAS, a petition of annexation for certain lands situated in the Southeast Quarter of the Southwest Quarter, Section 27, Township 105 North, Range 14 West, Olmsted County, Minnesota, has been presented to the Village Council of Stewartville, Minnesota, and whereas thirty (30) days posted notice and two weeks published notice of the hearing on the proposed annexation was had and whereas the hearing on the proposed annexation was held _____, 1966 at 7:30 P.M. in the chambers of the Village Council;

And Whereas, the Village Council of Stewartville, Minnesota has determined that the annexation will be to the best interests of the Village of Stewartville and the territory affected;

The Village Council of Stewartville, Minnesota does ordain as follows:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville; The West 525 feet of the South 1,033 feet of the Southeast Quarter of the Southwest Quarter of Section 27, Township 105 North, Range 14 West, containing 12.0 acres more or less.

2. The Village Clerk is hereby instructed to file a certified copy of this ordinance in the office of the County Auditor and one in the office of the Secretary of State.
