
Dear Mr. Lee:

1.27 AN ORDINANCE ADOPTING CERTAIN TERRITORY TO THE CITY OF PIPESTONE, MINNESOTA.

The Common Council of the City of Pipestone, Minnesota do ordain as follows:

Section 1. All that part of the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 12-106-46 described as follows, to-wit: Commencing at a point where the east line of the northerly extension of 3th Avenue NW, Pipestone, Minnesota intersects the north line of the right-of-way of the Chicago, Milwaukee St. Paul and Pacific Railway; running thence easterly along the north right-of-way line a distance of 677.3 feet to the east line of a northerly extension of 6th Avenue NW, Pipestone, Minnesota; thence north along said east line of 6th Avenue NW for a distance of 251.7 ft. to the south line of a westerly extension of 4th Street NW, Pipestone, Minnesota; thence west along said south line of 4th Street NW for a distance of 695.6 feet to the east line of 3th Avenue NW; thence south along said east line of 3th Avenue NW for a distance of 239.5 feet to the place of beginning, AND

A tract of land in the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 12-106-46, described as follows, to-wit: Beginning at a point 40.00 feet west of the NW corner of Lot 6, Block 7, Original Plat of the City of Pipestone, Minnesota; thence westerly along the south line of 4th Street NW 363 feet to the northerly extension of the east line of 6th Avenue NW; thence northerly for 80 feet to the north line of said 4th Street NW; thence easterly along said line of 4th Street NW to the northerly extension of the center line of 5th Avenue NW; thence southerly along said center line extension of 5th Avenue NW for 80 feet to the true point of beginning, all in the County of Pipestone, State of Minnesota; now owned by PAN-O-OLD REALTY COMPANY, A CORPORATION, and being contiguous to and abutting on the Corporate limits of the City of Pipestone, is hereby declared to be a part of the City of Pipestone, Minnesota.

Section 2. This Ordinance shall take effect and be in force from and after its passage and publication.
