

1.28 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE  
CITY OF PIPESTONE, MINNESOTA.

The Common Council of the City of Pipestone, Minnesota do  
ordain as follows:

Section 1, The land described as follows, to-wit: The North 550 feet of Lot G and the North 550 feet of Lot H, Stuarts Subdivision of the North one-half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section Thirteen (13), Township One-hundred-six (106), Range Forty-six (46), Pipestone County, Minnesota, excepting therefrom the following described land, to-wit: The West 80 feet of the East 217.4 feet of the North 183 feet of Lot H, Stuarts Subdivision of the North one-half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section 13, Township 106, Range 46, and excepting the following described land, to-wit: The West 120 feet of the East 137.4 feet of the North 183 feet of Lot H, Stuarts Subdivision of the North One half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section 13, Township 106, Range 46, Pipestone County, Minnesota, and excepting the North 333 feet of the East 17.4 feet of Lot H and the North 333 feet of the west 82.6 feet of Lot G of Stuarts Subdivision of the North One-half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section 13, Township 106, Range 46, Pipestone County, Minnesota, and excepting the East 80 feet of the West 162.6 feet of the North 183 feet of Lot G, Stuarts Subdivision of the North one-half ( $N\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section 13, Township 106, Range 46, Pipestone County, Minnesota, all in the County of Pipestone, State of Minnesota; now owned by Lee De Griselles, whose wife's name is Byrdella De Griselles, and being contiguous to and abutting on the corporate limits of the City of Pipestone, is hereby declared to be a part of the City of Pipestone, Minnesota.

Section 2, This Ordinance shall take effect and be in full force from and after its passage and publication.
