ORDINANCE NO. 89

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN PLATTED AND UNPLATTED LAND NOT EXCEEDING THE VILLAGE LIMITS.

WHEREAS, a certain petition dated May 9, 1966, requesting annexation of certain territory was duly presented to the Council on the 12th day of May, 1966.

WHEREAS, the quantity of land embraced within the area described in the amended petition and bounded as described as approximately 7 acres of platted and unplatted land, no part of which is included within the limits of an incorporated city, village or berough; and

WHEREAS, the petition was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WHEREAS, the land described in the petition abuts upon the Village limits at the northerly and northeasterly boundary thereof: and

WHEREAS, copies of said Petition have been filed with the Municipal Commission, the Town Board of the Town of Chisago Lake, and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be annexed is located, and

WEEREAS, the boundaries of no other municipality abut upon the boundaries of the land to be so annexed, and

WHEREAS, no witten objections to said annexation have been submitted to the Municipal Commission or the Village of Lindstrom by the Chisago Lake Town Board or the Chisago County Board of Commissioners within thirty (30) days after said

filing and the time allows pursuant to law, and

WHEREAS, no petition for incorporation or annexation is pending before the Municipal Commission including all or any part of the land proposed to be annexed and herein described;

The Council of the Village of Lindstrom, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village Limits and is urban in character; and (3) that none of said territory is now included within the limits of any incorporated city, village or borough, part of which is platted and part of which is unplatted and does not exceed 200 acres in area.

Section 2. Territory annexed. The corporate limits of ; the Village are hereby extended to include the platted and unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

Lot Five (5) and that part of Lot Six (6) lying West of the established Road in Block One (1) of Andrews Beach, according to the plat thereof on file and of record in the Office of the Register of Deeds in and for Chisago County, Minnesota.

All that part of Gov. Lot Six (6). Section Thirtyfour (34), Township Thirty-four (34), Range Twenty (20), described as follows, to-wit:

Beginning at a point 412.65 feet East of the Northwest corner of Lot Three (3) of Andrews Beach, according to the plat thereof on file in the office of the Register of Deeds in and for Chisago County; thence North 040 24' West, 624.65 feet; thence North 88° 06' East, 208.0 feet to the West line of a public road; thence South 200 14' East along the West line of public road, 216.2 feet; thence South 030 44' East along said West line of public road, 420.5 feet; thence South 880 02' West, 260.35 feet to the point of beginning. Above described parcel containing 3.7 acres more or less,

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor of Chisago County, Minnesota.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified Opies as directed in Section 3.
