
The Municipal Commission acknowledges receipt of

ORDINANCE NO. 335

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota by all the owner's of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

All that part of the Northwest Quarter (NW $\frac{1}{4}$) of Section Nine (9), Township One Hundred Eleven (111) North, Range Forty-one (41) West of the 5th Principal Meridian, in Lyon County, Minnesota, described as follows: Beginning at the SE corner of Lot 9, Block 2, DeSchepper's First Addition, City of Marshall, Minnesota; thence North along the East line of said Block 2, DeSchepper's First Addition, 449.4 feet to the North line of said Section 9, thence S 89 degrees, 41 minutes E and along the North line of said Section 9, a distance of 136.3 feet to a point 132 feet southwesterly and at right angles from the southwesterly line of Emery Street in said City of Marshall; thence S 45 degrees, 14 minutes E, 291.6 feet; thence N 44 degrees, 46 minutes E 132 feet; thence S 45 degrees, 14 minutes E, 403.89 feet; thence southeasterly 150.22 feet through an angle of 45 degrees, 04 minutes along a tangent curve concave to the southwest, having a radius of 190.99 feet; thence tangent to said curve S 00 degrees, 10 minutes E 519.89 feet; thence N 89 degrees, 48 minutes W 778.3 feet; thence S 00 degrees, 06 minutes W 1171 feet; thence N 89 degrees, 48 minutes W 135 feet; thence S 00 degrees, 06 minutes W 48 feet; thence N 89 degrees, 48 minutes W 423 feet; thence N 00 degrees, 06 minutes E 1091 feet; thence S 89 degrees, 48 minutes E 225 feet; thence N 00 degrees, 06 minutes E 64 feet; thence S 89 degrees, 48 minutes E 198 feet; thence N 00 degrees, 06 minutes E 54.10 feet; thence N 76 degrees, 59 minutes E 136.10 feet; thence N 29 degrees, 58 minutes W 45.20 feet; thence N 00 degrees, 09 minutes E 206 feet; thence easterly 62.50 feet through an angle of 13 degrees, 46 minutes along a curve concave to the South, having a radius of 260 feet; thence N 05 degrees, 27 minutes E 140.30 feet; thence N 89 degrees, 51 minutes W 75 feet; thence N 00 degrees, 09 minutes E 136 feet; thence S 89 degrees, 51 minutes E 22 feet; thence North 66 feet to the place of beginning.

Section 2. The above described tract of land contains less than 200 acres.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interest of the City of Marshall, Minnesota and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Marshall, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included, in, the City of Marshall, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
