ORDINANCE NO. 406

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. The territory hereinafter described, is now owned by the City of Worthington; and whereas said property is situated outside of, but contiguous to, and abutting on the corporate limits of the City, the City Council of said City of Worthington has determined to have such land included within the City of Worthington, Minnesota:

The Westerly 500 feet of the Northeast Quarter (NET) of Section 13, Township 102 North, Range 40 West and the Easterly 500 feet of the Northwest Quarter (NWT) of Section 13, Township 102 North, Range 40 West, and also the following described property:

Commencing at the Southeast corner of the Northeast Quarter (NE4) of Section 14, Township 102 North, Range 40 West, in the County of Nobles and State of Minnesota, which point is the point of beginning; thence West on the South line of said Northeast Quarter (NE4) a distance of 879.8 feet; thence North and parallel with the West line of said Northeast Quarter a distance of 700 feet; thence East and parallel with the South line of said Northeast Quarter (NE4) to the East line of said Northeast Quarter (NE4); thence South along the East line of said Northeast Quarter (NE4) of Section 14, a distance of 700 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 74.73 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on January 3, 1967, that said matter was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
