1.26 AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE, MINNESOTA.

The Common Council of the City of Pipestone, Minnesota do ordain as follows:

Section 1. The land, described by notes and bounds as follows, to-wit: a tract of land in the SW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 12, Township 186, Range 46 beginning at a point on the south line of 4th Street NW 403 feet west of the northwest corner of lot 6, Block 7, Original Plat to the City of Pipestone, Minnesota; thence northerly along a northerly extension of the east line of 6th Avenue NW for 60 feet to the westerly extension of the north line of 4th Street NW; thence westerly along said westerly extension of 4th Street NW to the west line of said section 12; thence southerly along said west line of said Section 12 to the North line of the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railway Co.; thence easterly along said line of right-of-way 13.00 feet to the northerly extension of the east line of 6th Avenue NW.; thence northerly and parallel to the west line of said Section 12 to the westerly extension of the south line of said 4th Street NW to the true point of beginning; all in the County of Pipestone, State of Minnesota; now owned by Howard H. Alben Jr. and being contiguous to and abutting on the incorporated limits of the City of Pipestone, so hereby declared to be a part of said City of Pipestone, Minnesota.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.
