



ROBERT L. HOFFMAN


of Minneapolis, Minnesota, as Special Assistant Attorney General to

meetings and advising said Board, extra board meetings, trial of cases
in court, investigations and such legal research as may be required.
Such compensation shall not include payment for travel time. Said
appointee shall serve at the pleasure of the Attorney General or
until this appointment shall be revoked or otherwise terminated in
accordance with law, and shall become effective January 3, 1967.




