AN ORDINANCE ANNEXING LAND INTO THE VILLAGE OF FOSSTON.

Section 1. That Arthur Berge and Theresa Berge, his wife have filed a Petition for Annexation of the following described property:

All that part of the South half of the Northeast Quarter (S₁ NE₁) of Section Four (4), Township One Hundred Forty Seven (147) North of Range Forty (40) West of the Fifth Principal Meridian described as follows; to-wit:

---Commencing 20.5 feet Northeasterly of the Northeast corner of Block 4, Johnson's Addition to Fosston on an extension of the East line of said Block 4, thence East 65 feet, thence North and parallel with the North-South quarter line of said Section to the North line of the South half of the Northeast Quarter of said Section 4, thence due East to a point on the North line of said South half of the Northeast Quarter of said Section 4 which is due North of the Northwest corner of Vig's Addition to the Village of Fosston, Minnesota, thence South along the Westerly boundary line of Vig's Addition to the Southwest corner of Vig's Addition, thence East to the Northwest corner of Lot 1, Block 2, North Fosston Addition to the Village of Fosston, thence southerly along the Westerly boundary line of Block 2, North Fosston Addition to the North line of Block 2, Lakeside Addition to the Village of Fosston, thence West along the North line of Lakeside Addition and Stephens Addition to the Village of Fosston to the Northwest corner of Block 1, Stephen's Addition to the Village of Fosston, thence Northeasterly to the point of beginning excepting therefrom the following described tract:

---Commencing at the Northwest corner of Lot 10, Block 1, Stephen's Addition to the Village of Fosston, thence East along the North line of said Block 1 a distance of 200 feet, then deflecting to the left at an angle of 78 degrees a distance of 200 feet, thence due West a distance of 200 feet thence Southwesterly to the point of beginning, Polk County, Minnesota,

with the Village Council of the Village of Fosston and Petition that the Village of Fosston extend the Village boundary to include said lands.

Section 2. The Village Council hereby determines, that the annexation of the above described real estate will be to the best interests of the Village of Fosston, Minnesota, and of the territory affected; that the territory described herein abuts upon the Village and is so conditioned as property to be subjected to Village government.

Section 3. THEREFORE, the Village of Fosston, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the Village of Fosston, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State and from and after its passage and publication.
