## ORDINANCE NO. 207

ORDINANCE NO, 207
AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORISS TO INCLUDE CER TAIN UNPLATTED LAND IN THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OB SECTION 35, TOWNSHIP 152, NORTH OF RANGE 50, WEST OF THE FIFTH PRINCIPAL MEIRDIAN, POLK COUNTY, MTNNESOTA, NOT EXCEEDING TWO HUNDRED ACRES, WHICH TRACT CONTAINS 7.417 ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:
Section 1. A. petition has been filed with the City Council of the Cily of Elast Grand Forks Minnesota, by Hilary D. Ryan and Catherine M. Ryan, his wife, being all of the ownens of the land hereinafter described, and Edward Surprenant, as the owner of a mortgage on said land hereinafter described, to have such land included within the Clity limits of the City of Eyast Grand Forks, Minnesolta; that copies of said petition were filed with the Minnesota Municipal Commission, the Jown Boand of Grand Forks Township and the County Board of Polk County, Minnesota; that more than 30 days have elapsed since such filings of said peitition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:
A tract of land in the Southwest Quanter of the Northeast Quanter (SW $1 / 4 \mathrm{NE} 1 / 4$ ) of Sec. tion Thirty-five (35), Township One Fundred Fifty-two (152) North, Range Fifty (50), West of the Fifth Principal Meridian, which tract is described as follows:
Commencing at a point on the Nonth-South Quarter Section line of Section 35, Township 152 North, Range 50, West of the 5th Principal Meridian, which point is 40.00 feet distant northerly from the center of said Section 35 and which point is the true point of beginning; thence proceeding northerly along said North . South Quarter Section line for a distamce of 539.69 feet; thence deflecting righit $90^{\circ} 00^{\prime} 00^{\prime \prime}$ and proceeding easterly for a disItance of 596.11 feet; thence deflecting right $90^{\circ} 00^{\prime} 00^{\prime \prime}$ and proceeding southerly on a line lvine oarallel to the aforesaid North-South Quarter Section
line for a distance of 544.31 feet to a point of intersection with a line lying parallel to and 40.00 feet distanit northerly from the East-West Quarter Section line in said Section 35; thence deflecting right $90^{\circ} 26^{\prime}$ 40" and proceeding westerly along said line lying parailel to the East-West Quarter Section for a distance of 596.13 feet to the true point of beginming, with said tract comprised of 7.417 acres in the Southwest Quarter of the Northeast Quarter (SW. $1 / 4 \mathrm{NE} 1 / 4$ ) of Section 35 Township 152 North, Range 50 , West of the 5th Principal Meridian.
Section 3. That the quantity of said land herein described is 7.417 acres.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.
2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota and of the territory affected.
3. That the temitory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is urban in character.
4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The comporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2 , and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the Coun ty Auditor and the Secretary of State of the State of Minnesota.

Section 7. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6. and be given the number 207.
