## ORDINANCE NO. 207

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 152, NORTH OF RANGE 50, WEST OF THE FIFTH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING TWO HUNDRED ACRES, WHICH TRACT CONTAINS 7.417 ACRES.

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Hilary D. Ryan and Catherine M. Ryan, his wife, being all of the owners of the land hereinafter described, and Edward Surprenant, as the owner of a mortgage on said land hereinafter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than 30 days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

A tract of land in the Southwest Quarter of the Northeast Quarter (SW ¼ NE¼) of Section Thirty-five (35), Township One Hundred Fifty-two (152) North, Range Fifty (50), West of the Fifth Principal Meridian, which tract is described as follows:

Commencing at a point on the North-South Quarter Section line of Section 35, Township 152 North, Range 50, West of the 5th Principal Meridian, which point is 40.00 feet distant northerly from the center of said Section 35 and which point is the true point of beginning; thence proceeding northerly along said North-South Quarter Section line for a distance of 539.69 feet; thence deflecting right 90° 00' 00" and proceeding easterly for a distance of 596.11 feet; thence deflecting right 90° 00' 00" and proceeding southerly on a line lying parallel to the aforesaid North-South Quarter Section

line for a distance of 544.31 feet to a point of intersection with a line lying parallel to and 40.00 feet distant northerly from the East-West Quarter Section line in said Section 35; thence deflecting right 90° 26' 40" and proceeding westerly along said line lying parallel to the East-West Quarter Section for a distance of 596.13 feet to the true point of beginning, with said tract comprised of 7.417 acres in the Southwest Quarter of the Northeast Quarter (SW ¼ NE ¼) of Section 35, Township 152 North, Range 50, West of the 5th Principal Meridian.

Section 3. That the quantity of said land herein described is 7.417 acres.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is urban in character.

4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor and the Secretary of State of the State of Minnesota.

Section 7. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6. and be given the number 207.

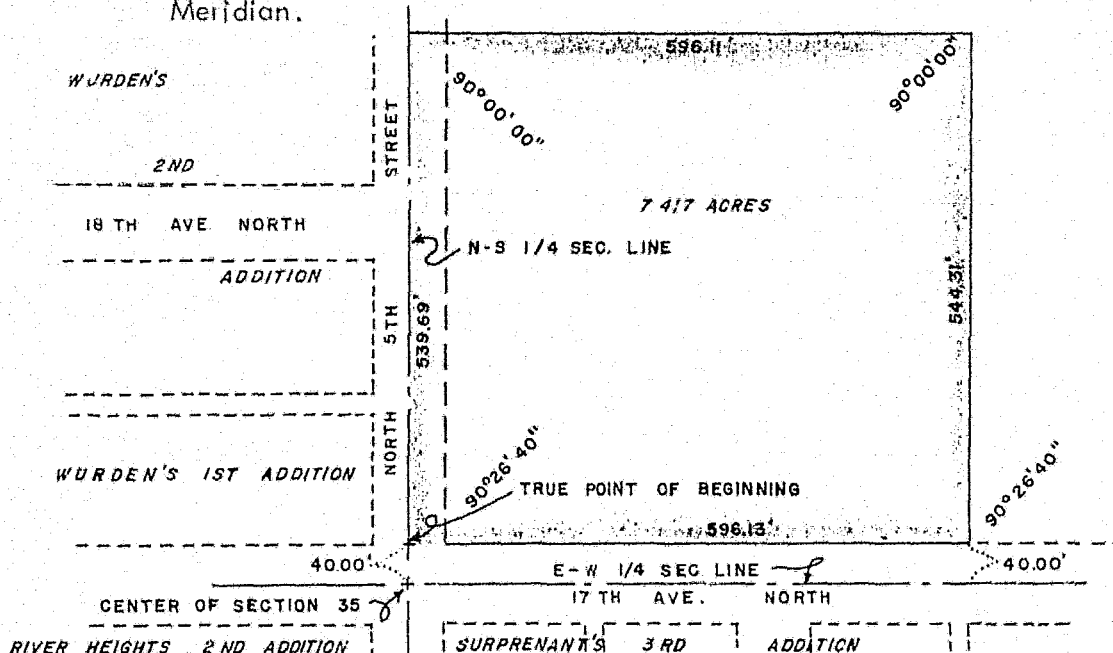
