The above entitled matter duly came on for hearing before the undersigned, one of the judges in and for said district, upon a petition of the plaintiff herein, pursuant to Section 6646, 6646, 1913 General Statutes of Minnesota, for the purpose of determining the constitutional liability of the stockholders of the defendant, Hill City Land, Loan and Lumber Company. Said hearing was held at the city of Rediff, Minnesota, on January 4th, 1918. Plaintiff appeared in person and by his attorneys, Taylor, Co. and Anderson; Defendant J.E. Abrahamson appeared by his attorney A.E. Thwing; Edwin L. Buch appeared by his attorney A.E. Thwing; there was no appearance for the remaining defendants.

From the evidence adduced at said hearing, it having been made to appear that the defendant Hill City Land, Loan & Lumber Company, a corporation, was organized on or about May 18th, 1905, under and by virtue of the laws of the state of Minnesota; and it appearing that said Hill City Land, Loan & Lumber Company has no assets whatever and has no means of paying the indebtedness of the said corporation and the expenses of receivership herein,

And it having been made to appear at said hearing, that the only existing indebtedness, aside from the expenses of the receivership herein, of said defendant corporation, is in the form of a judgment against said corporation in favor of J. Emerson Greenfield; that said judgment is in the sum of Six hundred forty six and 61/100ths dollars (\$646.61), and was duly docketed in the District court of Itasca county, Minnesota, on November 16th, 1911;

That the total amount now due on said judgment, which said amount includes interest to date at the rate of six per cent per annum, amounts to a total of eight hundred ninety four and 48/100ths dollars (\$894.48); that the probable expense of the receivership herein will be four hundred dollars (\$400.00), that the probable expense of collecting the assessments herein will be the sum of two hundred dollars (\$200.00); it having further been made to appear at said hearing, that at the time the indebtedness represented by the judgment heretofore described, was incurred by said corporation, the following persons were the only stockholders in said defendant corporation, to-wit: James Harper, Lewis L. Buck, Minnie F. Gill, whose name is now Minnie F. Cox, Minnie F. Cox, as guardian of Ernest L. Gill and Edward E. Gill, minors, Ernest L. Gill and Edward E. Gill; that at the time said indebtedness was incurred by said defendant corporation, said James Harper owned shares of stock in said company in the amount of two hundred fifty (250) shares; that L. L. Buck, at said time, owned shares of stock in said defendant corporation, in the amount of two hundred fifty (250) shares; that said Minnie F. Gill, whose name is now Minnie F. Cox, Minnie F. Cox, as guardian of Ernest L. Gill, and Edward E. Gill, minors, Ernest L. Gill and Edward E. Gill, at said time jointly owned shares of stock in said company in the amount of two hundred fifty shares (250).

It further having been made to appear at said hearing, that J. Emerson Greenfield was duly appointed as receiver of said defendant corporation, on the 14th day of June, 1912, and is now acting and is qualified to act as said receiver.

IT IS ORDERED THAT, That an assessment be made against the shares of stock heretofore described as owned by James Harper, Edwin L. Buck, Minnie F. Gill, whose name is now Minnie F. Cox, Minnie F. Cox, as guardian of Ernest L. Gill and Edward E. Gill, minors, Ernest L. Gill and Edward E. Gill, in the amount of Two dollars (\$2.00) for each of said two hundred fifty shares of stock owned by said persons as herein described; that said James Harper is hereby ordered to pay the sum of Two dollars (\$2.00) for each of said two hundred fifty shares of stock owned by him as heretofore set forth; that defendant E. L. Buck is hereby ordered to pay the sum of Two dollars (\$2.00) for each of said two hundred fifty shares of stock owned by him, as heretofore set forth; that Minnie F. Gill, whose name is now Minnie F. Cox, Minnie F. Cox, as guardian of Ernest L. Gill and Edward E. Gill, minors, Ernest L. Gill and Edward E. Gill, are hereby ordered jointly to pay the sum of Two dollars (\$2.00) for each of said two hundred fifty shares of stock jointly owned by them, as heretofore set forth.

IT IS ORDERED THAT, That payment of said amounts and assessments shall be made by said persons to the receiver of said defendant corporation, J. Emerson Greenfield, at his office in the Board of Trade Building, Superior, Wisconsin, and said J. Emerson Greenfield is hereby authorized to collect and receive the amounts assessed in this order; that said payments shall be made by said persons to said receiver on or before twenty (20) days from the date this order is served upon each of said defendants;

IT IS ORDERED THAT, That in case the amounts assessed herein against each or any of said parties, to-wit; James Harper, Edwin L. Buck, Minnie F. Gill, whose name is now Minnie F. Cox, Minnie F. Cox, as guardian of Ernest L. Gill and Edward E. Gill, minors, Ernest L. Gill and Edward E. Gill, or any part of said amounts shall not be paid by said persons to said receiver within said twenty days from the date of service of this order on said person or persons, the receiver herein,

J. Emerson Greenfield, shall forthwith prosecute an action against said person or persons, failing to pay said assessments ordered herein, regardless as to whether said person or persons be a resident or non-resident of this state, and wherever he or she may be found;

IT IS FURTHER ORDERED, that the receiver herein shall forthwith serve this order upon each of the said persons herein named, by mailing to each of them by registered mail, a copy of this order, addressed to each of said persons at their last known place of residence, dated this 9th day of April, A.D. 1918.
