ORDINANCE NO. 312

January Secretary of State

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF THIEF RIVER FALLS.

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1. Whereas petitioner Independent School District No. 564 of Pennington County, Minnesota, has petitioned the City Council of the City of Thief River Falls for the annexation of lands hereinafter described; the said School District is the owner of said lands; said lands do not exceed 200 acres; copies of the said petition have been filed with the Minnesota Municipal Commission, the town board of the Town of North and the county board of Pennington County, Minnesota; no objection to the said annexation has been submitted by the North town board, the Pennington County board, or of any other municipality within thirty (30) days of the said filing; therefore the City of Thief River Falls, pursuant to the provisions of Chapter 414.03 of the Minnesota Statutes, hereby annexes and incorporates within its boundaries the following described property:

The South Half of the Southeast Quarter ($S_2^{\frac{1}{2}}$ SE $_4^{\frac{1}{2}}$) of Section Twenty-seven (27) in Township One Hundred Fifty-four (154) North of Range Forty-three (43) West of the Fifth Principal Meridian less highway right-of-way and less that portion thereof previously conveyed to Thief River Falls Foundation by a deed dated March 23, 1960 and recorded in Book 89 of Deeds on page 577 of the records in the office of the Register of Deeds of said county and state, and excepting the West 500 Feet thereof (the said tract consisting of approximately 57 acres in area) subject to an easement appurtenant to and running with the land over said premises at such place as Independent School District No. 564 of Pennington County, Minnesota shall designate adequate for the use of private automobiles or light trucks for the benefit of the North Half of the Southeast Quarter ($N_2^{\frac{1}{2}}$ SE $_2^{\frac{1}{2}}$) of said Section Twenty-seven (27) so as to obtain access from said dominant tenement to Minnesota State Trunk Highway No. 1, a plat of said tract being hereto attached and made a part hereof.

Section 2. This ordinance shall be in force and effect from and after its passage, approval, publication and filing.
