

ORDINANCE NO. 67-28

AN ORDINANCE ANNEXING PROPERTY  
TO THE VILLAGE OF  
PRIOR LAKE, MINNESOTA

WHEREAS, Karl Mickus and Robert Mertons, being the sole owners of the following described property lying in Scott County, Minnesota:

The West Twenty (20) feet of Lot Two (2), Block Two (2), and all of Lot Three (3), Block Two (2), Lakeside Gardens, Scott County, Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said county and state;

have petitioned the Village Council of the Village of Prior Lake, Minnesota, to have the above described land, which lies outside of the Village of Prior Lake, Minnesota, annexed to the Village of Prior Lake, Minnesota; and

WHEREAS, the Village Council deems it advisable and in the public interest that said property be so annexed; and

WHEREAS, copies of the Petition for Annexation of said property have been filed with the Municipal Commission, the County Board of Scott County, and the Town Board of Spring Lake Township; and

WHEREAS, the Village Council does hereby find and determine that annexation will be to the best interest of the Village, and, that the above described property abuts upon the Village of Prior Lake, is not included in any other municipality, does not exceed two hundred acres, and, is so conditioned as properly to be subject to municipal government,

NOW THEREFORE, the Village Council of the Village of Prior Lake, Minnesota does ordain as follows:

SECTION I.

That the following described property, lying in Scott County, Minnesota, to-wit:

The West Twenty (20) feet of Lot Two (2), Block Two (2), and all of Lot Three (3), Block Two (2), Lakeside Gardens, Scott County, Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said county and state;

which lies outside the corporate limits of the Village of Prior Lake, Minnesota, be, and the same is hereby annexed to the Village of Prior Lake, Minnesota, and said property is hereby declared an addition to said Village.

Upon the date of execution of this ordinance, such property shall become a part of said Village as effectively as if it had been originally a part thereof.

SECTION II.

This ordinance shall take effect and be in force from and after its passage and publication, and after filing as hereinafter set forth. The Village Council is hereby instructed to cause certified copies of this ordinance to be filed in the office of the Register of Deeds, Scott County, Minnesota, the office of the County Auditor, Scott County, Minnesota, the office of the Secretary of the Municipal Commission, State of Minnesota, and, in the office of the Secretary of State of the State of Minnesota.
