AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby
ordain as follows:

Section 1.

WHEREAS the sole owner of the following described premises
situated in the City of Thief River Falls, County of Pennington
and State of Minnesota, to-wit:

Lots Nine (9), Fourteen (14) and Fifteen (15) of
Fairfield Addition to Thief River Falls,

has petitioned the City Council to have such land included within
the municipality and has filed copies of said petition with the
Municipal Commission of the State of Minnesota, with the Town Board
of the Township of North and with the County Board of the County of
Pennington, State of Minnesota and

WHEREAS the above described property abuts upon the boundaries
of the City of Thief River Falls and

WHEREAS no objections to the proposed annexation have been
submitted,

NOW, THEREFORE, it is hereby determined that the annexation
of said premises will be to the best interest of the City of Thief
River Falls and of the territory affected and the above described
premises are hereby declared annexed to the City of Thief River
Falls.

Section 2.

This ordinance shall be in force and effect from and after its
passage, approval, publication and filing with the Municipal Com-
mission, the Pennington County Auditor and the Secretary of State of
the State of Minnesota.

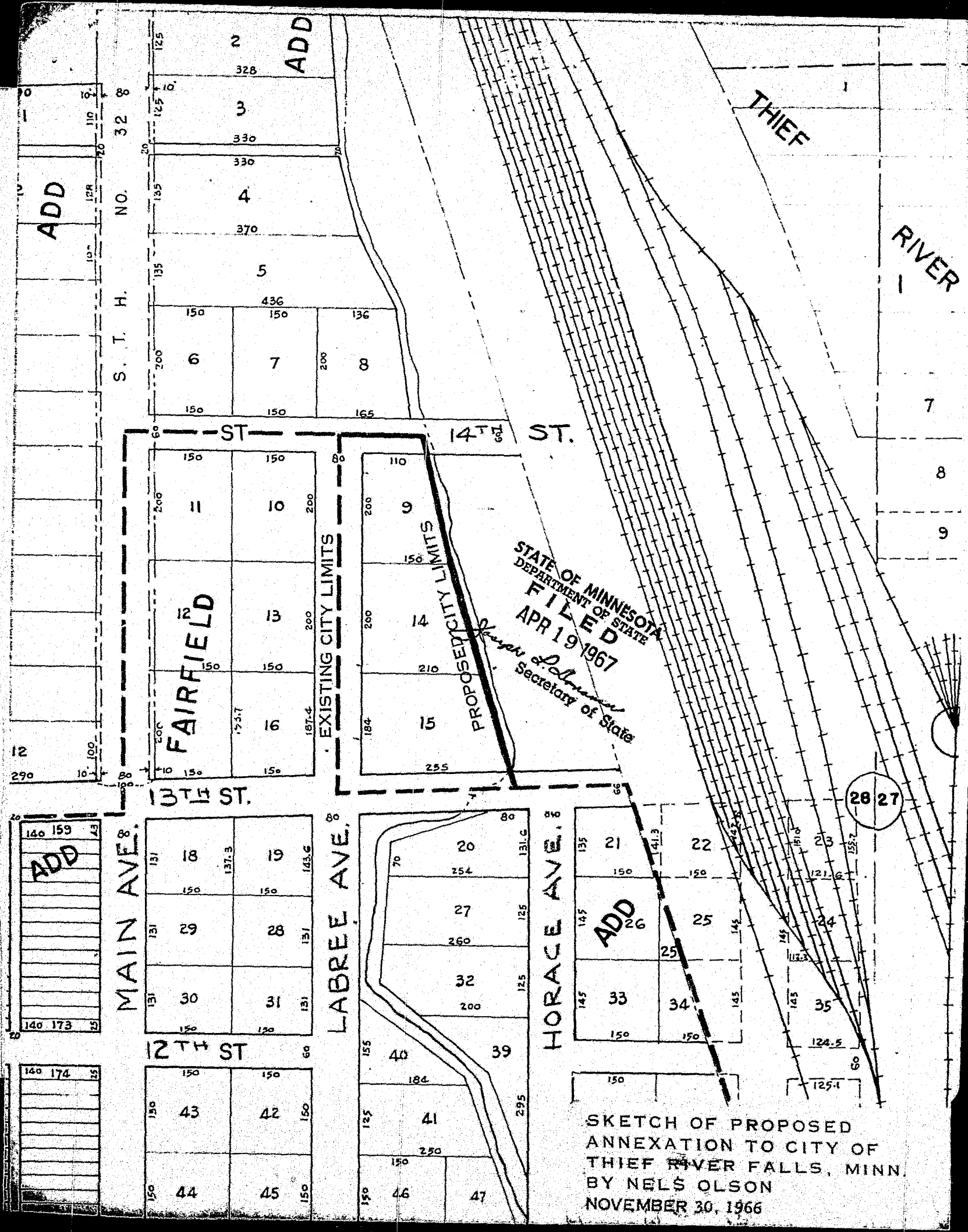

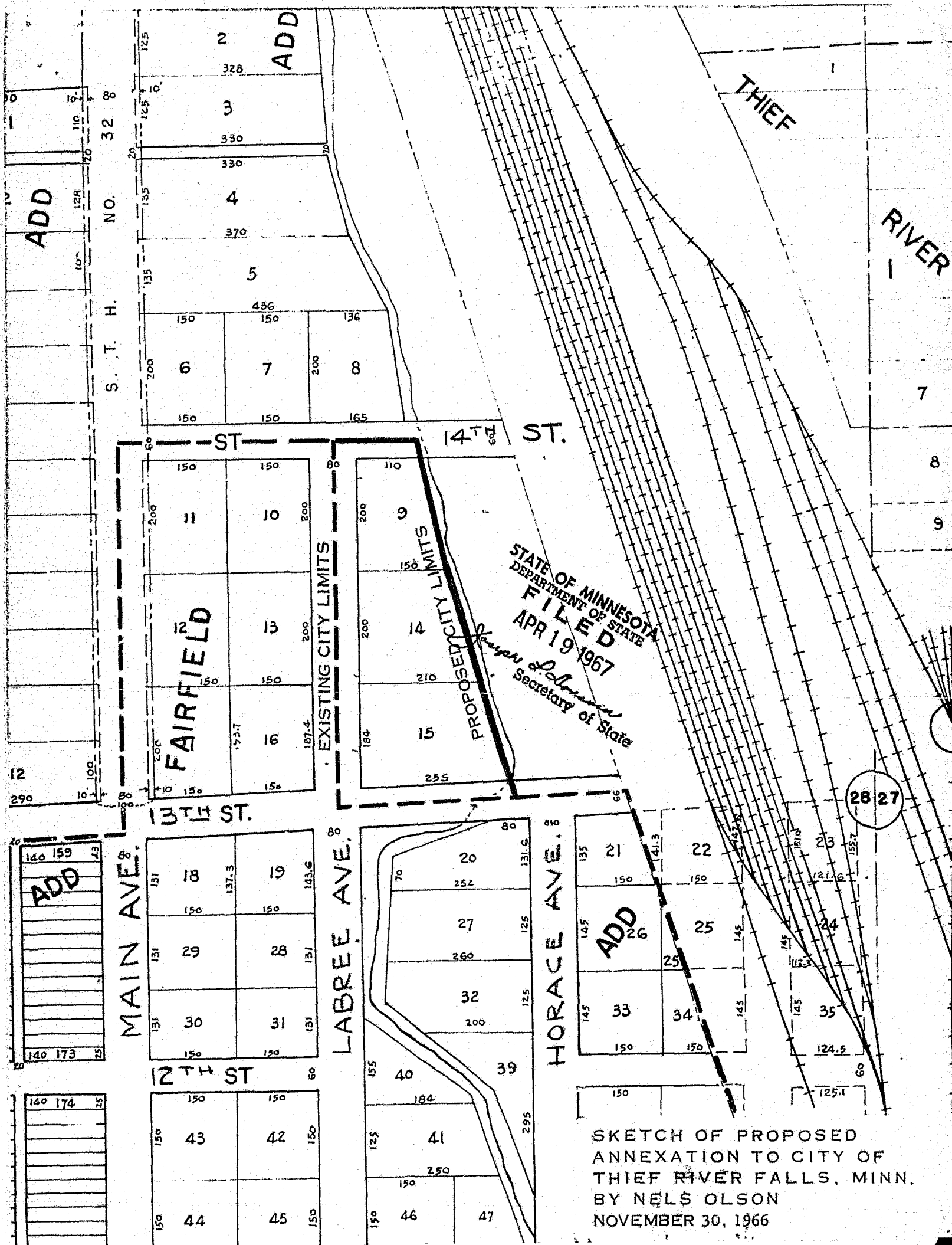

TO THE CITY COUNCIL OF THE CITY OF THIEF RIVER FALLS:

Your petitioners respectfully represent: That petitioners are the owners in fee of Lots Nine (9), Fourteen (14) and Fifteen (15) of Fairfield Addition to the City of Thief River Falls as shown on the attached plat; that said territory adjoins upon the incorporated property of the City of Thief River Falls; that said territory is platted; that said territory is bounded on the South by the center line of Thirteenth Street, on the West by the center line of LaBree Avenue, on the North by the center line of Fourteenth Street, and on the East by the Easterly lot line of Lots Nine (9), Fourteen (14) and Fifteen (15); that the quantity of land embraced within these boundaries is less than twenty-five (25) acres; that the number of actual residents is five (5) and all of these are from the household of petitioners; that there are three (3) buildings in the said territory, one of which is a dwelling house which is occupied by petitioners and the other two are unused breeder houses; that the said territory is now served by city water and streets, but not by city sewage disposal, fire and police protection; that said territory is located in the Township of North, County of Pennington; that the boundaries of no other municipality abut upon the boundaries of the land to be annexed.

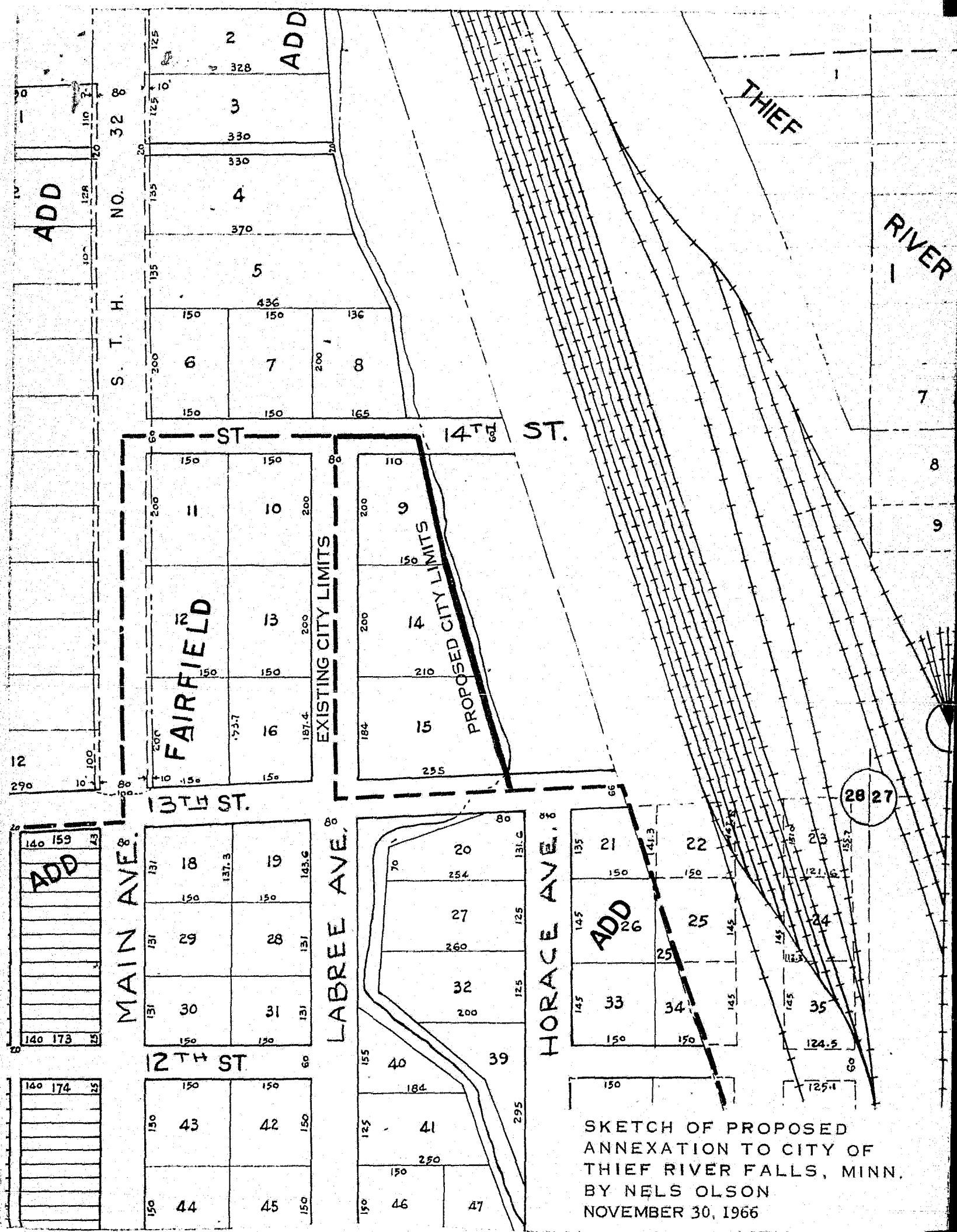

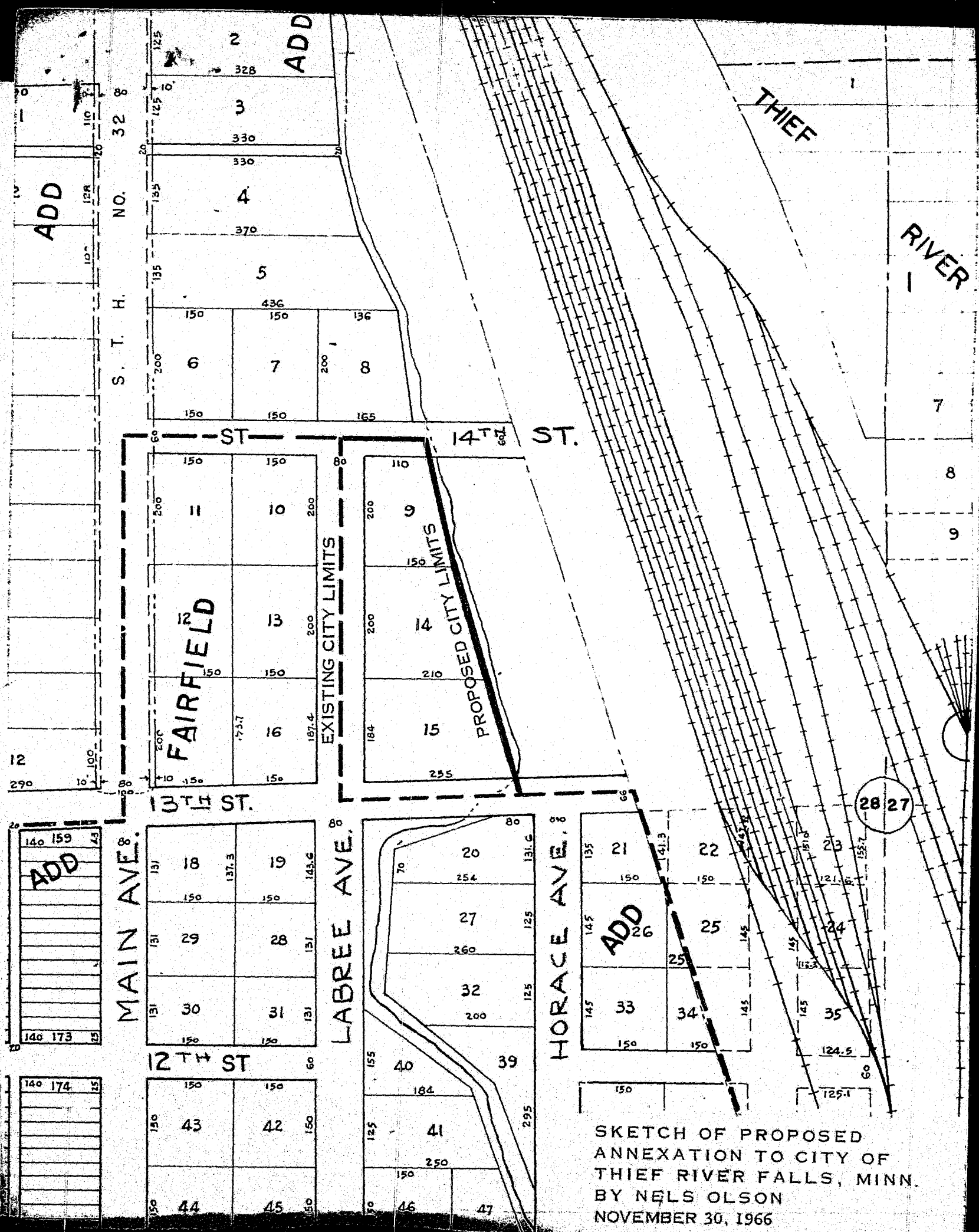
