ORDINANCE No. 36

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN LAND
OWNED BY THE VILLAGE OF MAPLE LAKE

THE VILLAGE COUNCIL OF MAPLE LAKE, MINNESOTA, ORDAINS:

Section 1) That pursuant to Minnesota Statute 414.03, Subd. 2, certain property owned by the Village of Maple Lake, Minnesota, legally described as follows:

The Northwest Quarter of the Northwest Quarter of Section 5, Township 120 North, Range 26 West; and all that part of the East Half of the Northwest Quarter of Section 5, Township 120 North, Range 26 West, lying within a distance of 200 feet on each side of a line described as follows: From a point on the West line of said Section 5, a distance of 509.05 feet South of the Northwest corner, run East-Southeasterly through a point on the North-South quarter line 1085.0 feet South of the North quarter corner, containing 12.58 acres more or less; And, further, all that part of the East Half of the Northwest Quarter, lying South of the above-described tract, except as follows: Beginning at the Southeast corner of the Northwest Quarter; thence North 1254.1 feet; thence N78°07'W distant 570.7 feet; thence S3°10'E distant 431.5 feet; thence S6°02'W distant 638.4 feet; thence S41°21'E distant 147.4 feet; thence S69°17'E distant 269.7 feet; thence S37°18'E distant 186.8 feet to the South line of said Northwest Quarter; thence S86°20'E, along said South line, a distance of 140 feet to the point of beginning; And all that part of the Northwest Quarter of the Northeast Quarter and Government Lot 3 of Section 5, Township 120 North, Range 26 West in Wright County, Minnesota, lying within a distance of 200 feet on each side of the following described line; From a point on the West line of said Section 5, 509.05 feet South of the Northwest corner of said Section 5 run East-Southeasterly through a point on the North-South quarter line 1085.0 feet South of the North Quarter corner; thence continue on said line for a distance of 398 feet, containing 3.65 acres more or less,

the village council has unanimously determined that it is to the best interest of the Village and to the best interest of the property to be annexed, that it be annexed.

Section 2) The tract hereinbefore described is, by this ordinance, declared to be annexed to the Village of Maple Lake, Minnesota.

Section 3) This ordinance shall take effect upon its passage and publication, and upon the filing of a copy of this ordinance with the Municipal Commission of the State of Minnesota, and the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
