

Meighen, Judge, Tenth Judicial District, dated the 15th day of June, 1922, as amended, a copy of which was filed in the office of the Secretary of State on the 20th day of June, 1922; which order was amended by the same judge of the same court by Order dated the 24th day of June, 1922, a copy of which amendment was filed in the office of the Secretary of State on the 25th day of June, 1922, with its principal office and place of business in the office of the Clerk of District Court in the Courthouse in the Village of Caledonia, Houston County, Minnesota.

The said District contains lands in the County of Houston.

That no work has been performed during the 20-year period immediately prior to the 21st day of May, 1965, and that no application has been made by such district for authority to continue its corporate existence under provisions of Minnesota Statutes, Chapter 112, within one year after the 21st day of May, 1965.
