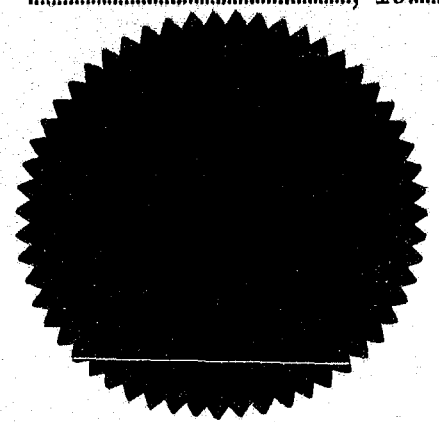

CONCLUSIONS OF LAW
ORDER

The above entitled matter was heard by the Court in Special Term at the Court House at Caledonia, Minnesota, on the 3rd day of April, 1967, at 11:00 o'clock a.m. Gordon C. Moosbrugger, Special Assistant Attorney General, appeared for the petitioner and there were no other appearances.

Upon the testimony, records, and proceedings herein and the files of the District Court in the matter of the proceedings for the organization of Houston County Drainage and Conservancy District Number One, the Court makes the following

FINDINGS OF FACT

I

The Houston County Drainage and Conservancy District Number One was established by Order of the District Court, Honorable John F. D. Meighen, Judge, Tenth Judicial District, dated the 15th day of June, 1922, as amended, a copy of which was filed in the office of the Secretary of State on the 20th day of June, 1922; which order was amended by the same judge of the same court by Order dated the 24th day of June, 1922, a copy of which amendment was filed in the office of the Secretary of State on the 28th day of June, 1922, with its principal office and place of business in the office of the Clerk of District Court in the Courthouse in the Village of Caledonia, Houston County, Minnesota.

II

The said District contains lands in the County of Houston.

III

That no work has been performed during the 20-year period immediately prior to the 21st day of May, 1965, and that no application has been made by such district for authority to continue its corporate existence under provisions of Minnesota Statutes, Chapter 112, within one year after the 21st day of May, 1965.

Based on the foregoing findings of fact, the Court makes the following

CONCLUSIONS OF LAW

The Houston County Drainage and Conservancy District Number One should be terminated as petitioned.

Therefore, the Court makes the following

ORDER

IT IS HEREBY ORDERED, that the corporate existence of the Houston County Drainage and Conservancy District Number One is hereby terminated as of the date hereof, and it is further ordered that a certified copy of these Findings of Fact, Conclusions of Law, and this Order be filed in the office of the Secretary of State by the petitioner.
