ORDINANCE NO. 124

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FLOODWOOD TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated January 31, 1967, requesting amnexation of the territory hereinafter described was duly presented to the council on the 14th day of February, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2.6 acres, more or less, of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by president and secretary of the corporation, who is the sole owner of the property; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was not held since no objections were filed and the sole owner of the property signed the petition, and

WHEREAS, THE land described in the petition abute upon the Village limits at the west boundary of the village thereof;

THE COUNCIL OF THE VILLAGE OF FLOODWOOD, MINNESOTA, ordains:

Section 1. The Village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:
