ORDINANCE NO. 139

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF NEW PRAGUE TO IN-CLUDE CERTAIN UNINCORPOR-ATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition re-questing annexation of the territory hereinafter described was duly presented to the New Prague City Coun-
