AN ORDIANCE ANNUAING LAND COMED AND OCCUPIED BY INDEPENDENT SCHOOL DISTRICT 857 TO THE VILLACE OF LANGESTON

The Village Council of the Village of Lewiston, hereby ordnins;

That Independent School District No. 857 Lowing heretofore submitted to this Council a Petition for Annexation, dated Cetober 12, 1966 for the annexation to said Village of the lands hereinafter described, owned by said School District and abutting upon the limits of said Village, and that;

- (1) School District 657 is the owner in fee of all of said lands excepting lands used by the County for highway purposes, and that said potition has been executed by the Chairman and Clerk of said School District.
- (2) That said land is unplatted and does not exceed 200 acros and that copies of said position have been filed with the State of Minnesota, Municipal Commission and with the Village of Lewiston, the term board of Utica Township and the County B and of Winone County and that all of said lands lie within the County of Winone and the Town of Utica and butto upon the boundaries of the Village of Lewiston.
- (3) That thirty days have clapsed from the time of filing said petition and that no objections thereto have been submitted to the Village of Louiston.

That this Council finds that the sumexptions of said lands are to the best interests of the Numicipality and of the territory affected, which territory is described as follows, to-wit:

All of the Southwest Juster (SW) of the Northwest Juster (NU) of Section Thirteen (13) Township Cae Sunded Six (106) North Mange Nine (9) West and including the following described tract of land, te-wit: Commencing on the West line of said Section Thirteen (13) at the interesection thereof with the South Line of Minnesota Highway No. 14, proceeding thence East a distance of thirty-three feet, thence South seventy fee; thence West thirty-three feet, thence North seventy feet to the point of begining. Excepting therefrom the following described tracts:

a. That parcol of land formerly conveyed by Marvin A. Packrotter and Irono E. Beckroiter, husband and wife, to Friebert W. Sachreiter and Ada Sachreiter, Justind and wife, in that cortain varranty lead dated May 12, 1943, and filed for record in the office of the beginter of Deeds inend for winom County, winnessta, on December 17, 1943, in No. k 191 of Deces, page 419, in which leed the land is described as follows: Commencing at a joint 33 feet Sant of the west line of said hection Thirteen (13) on the South Line of Minnesota Highway No. 14, proceeding thence in an casterly direction 225 feet, thence South 70 feet; thomas west 225 feet, thence North 70 feat to the point of beginning.
