
Dear Mr. Poole:

AN ORDINANCE ANNEXING LAND OWNED AND OCCUPIED BY
INDEPENDENT SCHOOL DISTRICT 857 TO THE VILLAGE OF
LEWISTON

The Village Council of the Village of Lewiston, hereby ordains;

That Independent School District No. 857 having heretofore submitted to this Council a Petition for Annexation, dated October 12, 1966 for the annexation to said Village of the lands hereinafter described, owned by said School District and abutting upon the limits of said Village, and that;

(1) School District 857 is the owner in fee of all of said lands excepting lands used by the County for highway purposes, and that said petition has been executed by the Chairman and Clerk of said School District.

(2) That said land is unplatted and does not exceed 200 acres and that copies of said petition have been filed with the State of Minnesota, Municipal Commission and with the Village of Lewiston, the town board of Utica Township and the County Board of Winona County and that all of said lands lie within the County of Winona and the Town of Utica and butts upon the boundaries of the Village of Lewiston.

(3) That thirty days have elapsed from the time of filing said petition and that no objections thereto have been submitted to the Village of Lewiston.

That this Council finds that the annexations of said lands are to the best interests of the Municipality and of the territory affected, which territory is described as follows, to-wit:

All of the Southwest Quarter (SW_{1/4}) of the Northwest Quarter (NW_{1/4}) of Section Thirteen (13) Township One Hundred Six (106) North Range Nine (9) West and including the following described tract of land, to-wit:
Commencing on the West line of said Section Thirteen (13) at the intersection thereof with the South line of Minnesota Highway No. 14, proceeding thence East a distance of thirty-three feet, thence South seventy feet; thence West thirty-three feet, thence North seventy feet to the point of beginning. Excepting therefrom the following described tracts:

a. That parcel of land formerly conveyed by Marvin A. Sackreiter and Irene E. Sackreiter, husband and wife, to Friebert W. Sackreiter and Ada Sackreiter, husband and wife, in that certain warranty deed dated May 12, 1943, and filed for record in the office of the Registrar of Deeds in and for Winona County, Minnesota, on December 17, 1943, in Book 191 of Deeds, page 419, in which deed the land is described as follows: Commencing at a point 33 feet East of the west line of said Section Thirteen (13) on the South line of Minnesota Highway No. 14, proceeding thence in an easterly direction 225 feet, thence South 70 feet; thence West 225 feet, thence North 70 feet to the point of beginning.

b. Land used by the State and Township for highway purposes.

That this ordinance is enacted pursuant to the provisions of Minnesota Statutes Annotated, Section 414.03, subdivisions 1 through 3, and shall become effective upon the publication thereof and upon filing a copy with the Municipal Commission State of Minnesota, the County Auditor of Winona County and the Secretary of State, State of Minnesota.

AND IT IS HEREBY ORDAINED, by the Village Council of the Village of Lewiston, Minnesota that the above described lands are declared to be annexed to the Village of Lewiston, Minnesota.
