## ORDINANCE NO. 352

OULIXF

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDED TO INCLUDE CERTAIN LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than ten (10) acres of land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by four (4) owners, constituting a majority, but not all of a total number of five (5) owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the City of Montevideo, Minnesota, on the proposed annexation after at least 30 days posted notice; and

WHEREAS, the land described in the petition abuts upon the City limits at the Easterly boundary thereof;

The City of Montevideo does ordain:

<u>Section 1.</u> The city council hereby determines (1) that the annexation will be to the best interest of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

<u>Section 2.</u> <u>Territory Annexed</u>. The corporate limits of the city are hereby extended to include the lands described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

> Parcel A. Lots One (1), Two (2), Three (3), Four (4), Five (5) and Six (6) in Tomes Subdivision.

That part of Sublot Six (6) of Odd Fellows Subdivision into sublots in said East Half ( $E_{2}$ ) of said Northeast Quarter (NE<sub>4</sub>) commencing at the Southeast Corner of said Sublot Six (6), running thence north seventy feet (N 701), thence west Three Hundred feet (W 3001), thence South Seventy feet (S 70') and thence East Three Hundred feet (E 3001) to the point of beginning.

Parcel C. Beginning at a point Seventy-five feet North (75' N) of the Southeast (SE) corner of Sublot Five (5) in the Odd Fellows Subdivision into Sublots in said East Half  $(E_2)$  of said Northeast Quarter (NE<sub>4</sub>), running thence North One Hundred feet (1001), thence West Two Hundred Fifty feet (W 250'), thence South One Hundred feet (S 100'), Thence East Two Hundred Fifty feet (E 250') to the point of beginning.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
