ORDINANCE NO. 1391
AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land, Not exceeding Two Hundred Acres in Area. All being in Sections five and Six, Township One Hundred Six North, Range Thirteen West, Olmsted County, Minnesota.

The Common Council of the City of Rochester do ordain:

Section 1. The City of Rochester, Minnesota, is the owner of the lands described herein, which lands abut upon the present territorial limits of the City of Rochester. The said lands owned by the City are located in Marion Township, Olmsted County, Minnesota, and are described as follows:

All that part of the southwest one quarter and all that part of the west one half of the southeast one quarter, in section 5, township 106 north, range 13 west, Olmsted County, Minnesota, which lies south of trunk highway No. 14; also, all that part of the northwest one quarter of the southeast one quarter in section 5, township 106 north, range 13 west, Olmsted County, Minnesota which lies south of trunk highway No. 14.

Section 2. The quantity of unplatted land described in Section 1 above is approximately 175 acres.

Section 3. The Common Council of the City of Rochester hereby determines that the lands described in Section 1 abut upon the present territorial limits of the City of Rochester, said lands have been dedicated to public park and recreational purposes, are so conditioned as to be properly subjected to Municipal Government, and the annexation of said lands will be in the best interest of the City of Rochester and of the lands affected.

Section 4. Therefore, the lands described in Section 1 above are hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if they had originally been a part thereof.

Section 5. This ordinance shall take effect and be in full force from and after its official publication and from and after the filing of the certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
