#### ORDINANCE NO. 208

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SAUK RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

(1) The governing body of the Village of Sauk Section 15:39 Rapids, Minnesota resolves to have the following land included within the Village of Sauk Rapids, Minnesota:

All that part of the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section Twenty-three (23) Township Thirtysix North (36N), Range Thirty-one West (31W) described as follows:


