
Dear Mr. Melchert:

ORDINANCE NO. 47

AN ORDINANCE AMENDING ORDINANCE NO. 46 OF THE VILLAGE OF WATERTOWN, ANNEXING CERTAIN LANES INTO THE CORPORATE LIMITS OF THE VILLAGE OF WATERTOWN, MINNESOTA

The Village Council of the Village of Watertown, Carver County, Minnesota, Ordains:

That Section 2 of Ordinance No. 46 of the Village of Watertown be amended by deletion of same in its entirety, and by inserting therein the following:

Section 2. Territory Annexed. The corporate limits of the Village of Watertown are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

All that part of Outlots 98 and 99 situated in the North-east Quarter of Section 8, Township 117, Range 25, lying Westerly of the Easterly right of way line of Minnesota Trunk Highway No. 25, according to the Plat of the Village of Watertown on file and of record in the office of the Register of Deeds in and for Carver County, Minnesota.

ORDINANCE NO. 46

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE  
INCORPORATED LIMITS OF THE VILLAGE OF WATERTOWN,  
MINNESOTA

WHEREAS, A certain Petition, dated the 16th day of September, 1965, and requesting annexation to the Village of Watertown of certain territory described below, was duly presented to the Village Council of the Village of Watertown, on the 22nd day of September, 1965, pursuant to Minnesota Statutes, Section 414.03; and

WHEREAS, The Village Council finds that said Petition was signed by all of the owners of said lands and is suitable and proper in all respects; and

WHEREAS, copies of said Petition were duly forwarded to the Clerk of the Town Board of the Township of Watertown, The County Auditor of the County of Carver, and the Municipal Commission of the State of Minnesota, as required by law, and that more than thirty days have elapsed since said copies were sent to and received by said parties,

THE VILLAGE COUNCIL OF THE VILLAGE OF WATERTOWN, CARVER COUNTY, MINNESOTA, ORDAINS:

Section 1. Declaration. It is hereby determined that a copy of said Petition was duly mailed, as required by law, to the Town Board of the Township of Watertown, the Carver County Board, and the Municipal Commission of the State of Minnesota, and that no objection to the proposed annexation has been made by any of said parties or filed with the Village Council; that the territory described below abuts upon the present corporate limits of the Village of Watertown; that said lands do not

exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as property to be subjected to municipal government; and that the annexation of said lands would be to the best interests of the Village of Watertown and the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the Village of Watertown are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

That part of Outlots 98 and 99, situated in the Northeast Quarter of Section 8, Township 117 North, Range 25 West, according to the plat of record, described as follows: Beginning at the northwest corner of said Outlot 98, thence South 3° 00' West along the west line of said Outlots 98 and 99 distance 1135.0 feet to the west right of way line of Trunk Highway No. 25, thence Northeasterly along said right of way line of said Highway distant 987 feet, more or less, to the north line of said Outlot 98, thence North 47° 43' West along said north line distant 449.0 feet to the point of beginning, containing 4.0 acres, more or less.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission of the State of Minnesota, the Secretary of State, and the Auditor of Carver County, as required by law.

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of this Ordinance as set forth in Section 3.
