

ORDINANCE NO. 184

An Ordinance annexing a part of the Southeast Quarter (SE 1/4) of Section 20, Township 30, Range 21 West, in Washington County, to the Village of Mahtomedi, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by the owners of the land hereinafter described, in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village, and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described as follows:

All that part of the Southeast Quarter (SE 1/4) of Section 20, Township 30, Range 21 West, described as follows:

Beginning at the Southeast corner of Lot 3, of East Shore Garden Lots, as surveyed and platted and now on file and of record in the office of the Register of Deeds, Washington County, Minnesota, and running thence Easterly on a projection of the South line of said Lot 3, a distance of 246 feet; thence Northerly and parallel to the East line of Lot 3, a distance of 330 feet to the center line of Maple Street; thence Westerly and parallel to the South line of Maple Street, a distance of 246 feet; thence South along the East line of said Lot 3, a distance of 330 feet to the point of beginning, subject to East Avenue.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.


Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
