ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Robert F. Vinnegan and Dorothy M. Finnegan, his wife, as owners of the following described real estate, to have such lands included in the City of Mankato, blue Earth County, Minnesota, to-wit:

Lots 1, 2, 3, 4, 5, 6, 7 and 8 of Finnegen's Addition to Mankato, Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County and State.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesots, an incorporated city, having a population of not less than 10,000 nor more than 30,000 pursuant to the last census.
