ORDINANCE NO. 205

An Ordinance extending the corporate limits of the City of Glencoe, McLeod County, Minnesota, to include certain unincorporated property abutting upon the corporate limits of said city,

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS:

1. That the corporate limits of the City of Glencoe, be and hereby are extended to include the unplatted property, abutting on the corporate limits of said city, described as follows;

Tract B of Registered Land Survey No. 2 and that part of Tract D of Registered Land Survey No. 2 described as follows: Commencing at the corner of Tract D of Registered Land Survey No. 2, said point also being the Southwest corner of Tract B of Registered Land Survey No. 2, thence south 89 degrees 28 minutes West along the Southerly line of said Tract D a distance of 331.00 feet to the Southwest corner of said Tract D, thence North 00 degrees 08 minutes East along the Westerly line of said Tract D a distance of 741.55 feet, thence South 89 degrees 43 minutes East along a line of said Tract D a distance of 68.25 feet, thence North 00 degrees 29 minutes East along a line of said Tract D a distance of 70.45 feet, thence North 89 degrees 19 minutes East a distance of 434.27 feet, thence South 00 degrees 31 minutes East a distance of 70.54 feet to the Northeast corner of said Tract B, thence South 89 degrees 28 minutes West a distance of 181.50 feet to the Northwest corner of said Tract B, thence South 00 degrees 31 minutes East along the Westerly line of said Tract B a distance of 741.55 feet to the point of beginning.

This ordinance takes effect from and after its passage and publication.


