THEREAS, The Board of Freeholders heretofore appointed by the Judge of the District Court, as provided for in Section 1343 of the General Statutes of the State of Minnesota 1913, and the laws amendatory thereto, have proposed to amend Section 213 of Chapter XV of the City Charter of the City of Pipestone, Minnesota, by adding thereto the following:

"AND THE WHOLE OR ANY PART OF THE EXPENCE OF SAME, AS THE COMMON COUNCIL SHALL DETERMINE, MAY BE DEFRAYED BY ASSECUMENT UPON THE REALESTATE BENEFITED THEREBY, IN PRO ORTION TO SUCH BENEFITS, WITHOUT REGARD TO CASH VALUEATION, TO BE DETERMINED AND LEVIED IN THE MANNER PROVIDED FOR IN CHAPTER EIV OF THIS CHARTER FOR THE MAKING OF LOGAL IMPROVEMENTS AND ASSESSMENTS, AND ALL PROVISIONS THEREIN CONTAINED, APPLYING TO MAKING OF LOCAL IMPROVEMENTS AND ACCESSMENTS FOR THE SAME, SHALL HEREINAUTER APPLY ALSO TO THE ESTABLISHMENT, MAINTENANCE AND EXTENSION, OF WATER WORKS AND THE LAYING AND EXTENSION OF WATER MAINS AND PIPES."

THEREFORE BE IT RESCLVED, That the adoption of said proposed amendment be submitted to a vote of the electors of said city at a special election & # & & & & & to be held on the 19th, day of August. 1918, at the regular polling places in the City Hall of said city, which time and places are hereby designated as the time and places when and where said election shall be held, the polls to be open from 6-30 O'clock in the forencon until 7-0'clock in the afternoon, and the City Clerk, is hereby directed to give the required notices thereof.
