Yourship Board Actorney ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Charles J. Burger and Marlene L. Burger, his wife, as owners of the following described real estate, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

TRACT A:

Beginning at a point on the South line of the Northeast Quarter of the Southeast Quarter of Section 17, Township 108 North, Range 26 West, 33.78 feet East of the Southwest corner of said Northeast Quarter of the Southeast Quarter, said point being on the centerline of a town road known as the "Hoffman Road"; thence North at right angles to said South line, 161.09 feet; thence North 85° 12° West along the South line of Atwood Terrace Addition to the City of Mankato, 70.00 feet; thence South parallel with the Easterly boundary line of the tract herein described 167.08 feet to the South line of the Northwest Quarter of the Southeast Quarter; thence East, along the South line of the Northwest Quarter of the Northwest Quarter of the Southeast Quarter of said Section 17, and along the South line of the Northeast Quarter of the Southeast Quarter of Said Section 17, 69.78 feet to the point of beginning.
