UNEREAS, a certain potition dated Edy 23. 1966, requesting ameration of the territory hereinafter described was duly presented to the Council on the 5th day of June 1967; and

WHEREAS, the quantity of land embraced within the area desoribed in the petition and bounded as described is 66 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHENEAS, the petition was signed by Independent School Dist. # 727. its Board of Education; and

FREREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality where boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS. THE LAND DESCRIBED in the petition abuts upon the Village limits at the north boundary thereof:

Section 1. The Village Council hereby determines (1) the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village Limits and is urban in character; and (3) that mone of said territory is now included within the limit of any city, village or borough.
