ORDINANCE NO. 164

An ordinance annexing certain lands to the City of Northfield.

The City of Northfield does ordain:

Section 1. A petition by all owners of part of the afterdescribed real estate to annex said real estate to the City of Northfield has been received; The City of Northfield owns the balance of said real estate; and said real estate is situated in the County of Rice, State of Minnesota, and is described as follows, to wit:

1. All that part of the West Half (W $\frac{1}{2}$ ) of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Two, Township One Hundred Eleven North, Range Twenty West (2-111-20), which lies South of the right-of-way of the Chicago Great Western Railway and North of the Cannon River,
2. That part of the East One-half (E $\frac{1}{2}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Two, Township One Hundred Eleven, Range Twenty West (2-111-20) lying South of the right-of-way of the Chicago Great Western Railroad,
3. The West Half (W $\frac{1}{2}$ ) of the East Half (E $\frac{1}{2}$ ) of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of said Section Two, Township One Hundred Eleven North, Range Twenty West (2-111-20),
4. The South Three-fourths (S  $\frac{3}{4}$ ) of the East One-half (E $\frac{1}{2}$ ) of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Two, Township One Hundred Eleven North, Range Twenty West (2-111-20),
5. The West One Rod of the North Twenty-one Rods of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Two, Township One Hundred Eleven North, Range Twenty West (2-111-20),
6. The South five acres of the West One-half (W $\frac{1}{2}$ ) of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of said Section Two, Township One Hundred Eleven North, Range Twenty West (2-111-20),
7. Commencing at the center of the South line of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Thirty-five, Township One Hundred Twelve North, Range Twenty West (35-112-20), thence running Eight Rods West, thence North Forty Rods, thence East Eight Rods, thence South on the center line of said Quarter Section to the place of beginning.

That said afore described real estate abutts on the city limits of the City of Northfield, Minnesota.

Section 2. That copies of said petition were duly served upon the Municipal Commission; Town of Bridgewater. Rice County, State of Minnesota; and the County of Rice, State of Minnesota; and, over thirty days has elapsed since service was made with no objections being filed to the annexation.

Section 3. That the City Council of the City of Northfield hereby determines that the annexation of the afore-described real estate will be for the

best interests of the City of Northfield and for the above described  
real estate.

Section 4. The real estate described in Section 1 is hereby annexed  
to the City of Northfield, a Municipal Corporation, pursuant to Minnesota  
Statutes..
