A petition by all owners of part of the afterdescribed real estate to annex said real estate to the City of Morthfield has been received: The City of Northfield owns the balance of said real estate; and said real estate is situated in the County of Rice, State of Minnesots, and is described as follows, to wit:

- 1. All that part of the West Half (Wi) of the Southwest Quarter of the Southeast Cuarter (SWI of SEI) of Section Two, Township One Hundred Fleven North, Range Twenty West (2-111-20), which lies South of the right-of-way of the Chicago Great Western Railway and North of the Cannon River,
- That part of the East One-half (Et) of the Southwest Quarter (SWt)
  of Section Two, Township One Hundred Eleven, Range Twenty West
  (2-111-20) lying South of the right-of-way of the Chicago Great
