
The Municipal Commission has found that your annexation Ordinance No. 99 now meets all the requirements of the Municipal Commission Act and Rules of Procedure.

ORDINANCE NO. 99

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FOLEY TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated November 29th, 1965, requesting annexation of the territory hereinafter described was duly presented to the council on the 7th day of December, 1965; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than two acres of platted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by the legal representative of the owner; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the easterly boundary thereof;

THE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, ORDAINS:

Section 1. That the village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

All that part of Lots Twenty-one (21), Twenty-two (22), Twenty-three (23), Twenty-four (24), Twenty-five (25), Twenty-six (26), and Twenty-seven (27), of Park Lots Addition to the Village of Foley, except those portions of certain of said lots lying within the limits of State Highway Number Twenty-three (23), and except those portion of said lots lying northerly and westerly of said State Highway, and except that portion of Lot Twenty-seven (27) lying south and east of said Highway except the east eight (8) rods thereof. And also excepting from said tract the following tract condemned and purchased by the State of Minnesota for road purposes: The East eight (8) rods of Lot 27, Park Lots Addition, lying southeasterly of State Highway 23, together with that part of Lots 22 to 26 inclusive of said Park Lots Addition to Foley lying southeasterly of said State Highway number 23, lying northwesterly of a line run parallel with and distant 75 feet southeasterly of the following described line: Beginning with the intersection of the center lines of Broadway and Marlin Street in Village of Foley; thence run northeasterly at an angle of 89°58' with the center line of said Broadway street (when measured from Northwest to Northeast) for 1660.04 feet; thence deflect to the right on a ten cord spiral curve of decreasing radius (spiral angle 3°45') for 300 feet; thence deflect to the right on a 2°30' circular curve (delta angle 19°47') for 500 feet and there terminating, which is of record in the name of Frank Wiltgen.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
