## ORDINANCE NO. 1110

## EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE WEST.

WHEREAS, the owners of the property hereinafter described filed a Potition requesting the emenation of the territory hereinafter described which was duly presented to the Council,

AND VALUEDS, the quantity of lend embraced within the oreo described in the Petition and bounded as described is less than 280 acres of plotted land,

AND WEREAS, the Polition was signed by all the owners,

AND WHEREAS, no objections to the ameration have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries obut upon the boundaries of the land to be amered.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA, DO ORDAIN:

SECTION 1: The City Council hereb, determines that the annexation shall be to the best interests of the City and of the territory effected; and that the territory described herein abuts the City limits and is urban or suburben in character; and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The Corporate Limits of the City are hereby extended to include the platted Lands as follows, and the same is hereby amiexed to and included within the City as effectually as if it had originally been a part thereof:

Lot B. Creatwood Hills First Addition in the Southwest Quarter of Section 4. Township 102 North, Range 18 West, except the following portion previously deeded to Darrell Ametrong and Margaret E. Ametrong by a dead recorded in Book 250 of Deeds, page 493: beginning at the most northerly corner of said Lot 5, thence Southwesterly along the northerly line of said lot to the most westerly corner thereof; thence southeasterly 25 feet along the vesterly line of said Lot; thence northeasterly on a line parallel with the northerly line of said lot to the costerly line thereof; thence northeasterly along the appearly line of said lot to the point of beginning.

SECTION 3: The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4: This Ordinance takes effect on its passage and publishing and the filing of the certified copies as directed in Section 3.
