## ORDINANCE NO. 89

AN CRIDINANCE EXCELLING THE CORPORATE LIMITS OF THE VILLAGE OF PULDA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING SOO ACRES IN AREA ABUITING UPON THE VILLAGE LIMITS.

CMERGAS, a certain potition dated May 16. 1867, requesting amountion of the territory hereinafter described was duly presented to the council on the 20th day of May, 1967; and

MANIERS, the quantity of land embraced within the area described in the petition and bounded as described to 6 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

CHERRICS, the potition was eigned by all of the owners of said lands; and

THEREAS, no objections to the ennexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be ennexed; and

WINDAS, the land described in the petition couts upon the village limits at the south boundary thereof:

The council of the village of Pulda, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the ammeration will be to the best interests of the village and of the territory effected; (2) that the territory described herein abuts upon the village limits and is urban or suburban in character; and (2) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Torritory Annoused. The corporate limits of the village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

The North 333 feet of Government Let 1, Section Thirty-Six (36) Township One Hundred Five (103) Range Forty (40) except the West 518 Feet thereof.

Section 3. Filing. The village clerk is hereby directed to file cortified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.
