## Ordinance No. Section 1100:05

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF GRAND RAPIDS TO INCLUDE CENTAIN UNINCORPORATED TERRITORY COMPLETELY SUN-ROUNDED BY LAND WITHIN THE VILLAGE LIMITS AND ABUTTING THEREON.

WHEREAS, cortain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this torritory is complotely surrounded on all sides by lands already included within the corporate limits of the Village and is deemed to be urban in character;

The Village Council of Grand Repids, Minnesota ordains:

<u>Soction 1</u>. <u>Territory Annexed</u>. The corporate limits of the Village of Grand Rapide, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory new is and has heretofore been completely surrounded by territory already included within the village limiter (NU2 of NU2, Section 20, T55N, R25N.
