WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough, and,

WHEREAS, this territory is completely surrounded on all sides by an area already included within the corporate limits of the city and is deemed to be urban in character.

The City Council of the City of Glencoe ordains:

<u>Section 1.</u> <u>Territory Annexed</u>. The corporate limits of the city of Glencoe, Minnesota, are hereby extended to include the platted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:
