
Dear Mr. Bengtson:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough, and,

WHEREAS, this territory is completely surrounded on all sides by an area already included within the corporate limits of the city and is deemed to be urban in character.

The City Council of the City of Glencoe ordains:

Section 1. Territory Annexed. The corporate limits of the city of Glencoe, Minnesota, are hereby extended to include the platted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Lots Nine, Ten, Eleven, Twelve, Thirteen, Fourteen, Fifteen, Twenty, Twenty-one, Twenty-two, Twenty-three, Twenty-four, Twenty-five, and Twenty-six (9, 10, 11, 12, 13, 14, 15, 20, 21, 22, 23, 24, 25, & 26) of Dahl's Second Addition.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.


