
Dear Mr. Muchlinski:

ORDINANCE NO. 36

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF IVANHOE TO INCLUDE CERTAIN
UNINCORPORATED PROPERTY OWNED BY AND ABUTTING
UPON THE LIMITS OF THE VILLAGE

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory abuts upon the corporate limits of the village at the north boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the village;

The village council of Ivanhoe ordains:

SECTION 1. Territory Annexed. The corporate limits of the Village of Ivanhoe are hereby extended to include the unplatte property described as follows now owned by the village:

The Northwest Quarter (NW_{1/4}) of Section Thirty-four (34), Township One Hundred Twelve (112) North, Range Forty-five (45) West of the 5th Principal Meridian.

SECTION 2. Filing. The village Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. Effective Date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in section 2.




