Ordinance No. 1841

An Ordinance extending the Corporate Limits of the City of Albert Lea to include certain unincorporated, unplatted land not exceeding 200 acres in area, abutting upon the City limits.

Introduced by Councilor William W. Hagar.

WHEREAS, a certain petition dated May 9, 1967, requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of May 1967; and

WHEREAS, the quantity of land enclosed within the area described in the petition and heretofore described to 41.12 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the Township, The County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the Northwestern City limits.

THE COUNCIL OF THE CITY OF ALBERT LEA, MINNESOTA, ORDINS:

Sec. 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is or is included within the limits of any city, village, or borough.

Sec. 2. Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

A tract of land in Lot 100 and Lot All
in Sec. 3-102-21 described as follows:

Beginning at the northeast corner of Lot 1 Block 17 in Shoreland Estates as platted and recorded in the office of the Register of Deeds in and for Freeborn County Minnesota; thence South 30°17' West, 29.67 feet; thence South 31° 11' West 191.93 feet; thence South 35°19' West, 71.97 feet; thence Southwesterly along the northwesterly line of Martin Road as follows: South 31° 11' West, 215 feet; thence Southwesterly 152 feet along the arc of a curve with a radius of 471.53 feet; thence South 50°32' West, 257 feet; thence South 30° 08' East 16 feet; thence South 50° 52' West 35 feet; thence Northwesterly 197 feet; thence North 32°30' West 113.1 feet; thence North 39° 08' East 455.5 feet to the next right of way line of Lakewood Boulevard thence South 30° 24' West, 142 feet; to the Northwest corner of tract annexed by ordinance #1537, February 20, 1962; thence West 36'; thence Northwesterly 310 feet along the west line of Lakewood Blvd which is also the east line of Shadow Park Subdivision; thence North along the east line of Shadow Park Subdivision 1400 feet to the south line of Midway Drive; thence South 54° 15' East along the said south line of Midway Drive 2100 feet; thence South 65° 20' East, 43 feet; to the

west line of Linnaker Drive; thence South 10° 46' West, 53 feet; thence South 6° 19' West, 48 feet; thence South 34° 27' East, 105 feet which point is the northeast corner of Lot 7 Block 22 Cleveland Addition; thence North 35° 56' East, 352.50 feet; thence North 35° 29' West, 105 feet; thence North 35° 56' West 100 feet to the place of beginning.

The above tract contains 61.12 acres.

Sec. 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Sec. 4. That the above property is hereby zoned as R-1 Residential.

Sec. 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
