
Dear Mr. Thompson:

ORDINANCE NO. 419

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON,  
MINNESOTA, TO INCLUDE CERTAIN UNPLATED LANDS.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON DO DECIDES:

SECTION 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

That part of Section 15, Township 102, Range 40, Nobles County, Minnesota, described as beginning at the Northwest corner of Lot Eight (8), Block Two (2), Homestead Hills First Addition to the City of Worthington, thence Northerly and parallel to the Southerly line of Section 15, Township 102 North, Range 40 West for 330 feet; thence Northerly at 90° for 570 feet, more or less, to the Southerly line of the Northwest Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section 15, Township 102 North, Range 40 West; thence Northerly along the Southerly line of said quarter-quarter line to the Northerly line of Homestead Hills Second Addition; thence Southerly along the Northerly line of Homestead Hills Second Addition and said line extended to the point of beginning.

and

That part of Section 15, Township 102, Range 40, Nobles County, Minnesota, described as beginning at the Southwest corner of Lot Eight (8), Block Two (2), Homestead Hills First Addition to City of Worthington; thence Northerly on a prolongation of the Southerly line of said Lot Eight (8), a distance of 100 feet; thence at right angles Northerly a distance of 125 feet; thence at right angles Easterly a distance of 100 feet to the Northwesterly corner of said Lot Eight (8); thence at right angles Southerly on the West line of said Lot Eight (8), to the point of beginning.

SECTION 2. The quantity of land embraced within the foregoing descriptions, and bounded and described is 6.07 acres.

SECTION 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on May 3, 1967, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

SECTION 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

SECTION 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon filing of the certified copies as directed in Section 6.
