ORDINANCE NO. 97

VILLAGE OF FOLEY, BENTON COUNTY, MINNESOTA

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

WHEREAS, the owner of the land described below abutting upon said Village has filed with the Village Clerk its petition asking that said land be annexed to the Village; and

WHEREAS, the Village Council of the Village of Foley has determined that the annexation of said land is in the best interest of the Village of Foley and of the territory affected thereby.

NOW, THEREFORE, THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDAIN AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley are hereby extended so as to include the following described parcel of land abutting upon said village:

Part of the East Half (E $\frac{1}{2}$ ) of Section Twenty-six (26), Township Thirty-seven (37) North, Range Twenty-nine (29) West, described as follows:

Commencing at East Quarter corner of Section Twenty-six (26), Township Thirty-seven (37) North, Range Twenty-nine (29) West, said quarter corner being on centerline of County Road #43, Benton County; thence following said road centerline on an assumed bearing of South 87°51' West 239.25 feet for point of beginning; thence North 363.0 feet; thence North 87°51' East 239.25 feet to the East line of Northeast Quarter (NE $\frac{1}{4}$ ) of said Section Twenty-six (26); thence North on said East line 797.31 feet; thence South 87°51' West to West line of East Half (E $\frac{1}{2}$ ) of said Section Twenty-six (26); thence Southerly on said West line of East Half (E $\frac{1}{2}$ ) of Section Twenty-six (26) to centerline of said County Road #43; thence Easterly on said road centerline to point of beginning, which is of record in the name of Independent School District Number Fifty-one (51), a municipal corporation under the laws of the State of Minnesota.

Section 2. That none of the real estate described above is platted and that the total area of all of said real estate is less than 200 acres, and that the annexation of said land to the village limits shall be deemed complete upon the publication of said ordinance and the recording of the said ordinance with the Register of Deeds and the filing of a certified copy thereof with the County Auditor, Secretary of State and the Minnesota Municipal Commission and the approval of same by said commission.

Passed at a regular meeting of the Village Council held on the 6th day of April, 1967.
